

NCOS Fall Congress Relocation Announcement

October 11, 2024

Due to the impact of Hurricane Helene on Asheville and the entire western North Carolina area, the NCOS has made the difficult decision to relocate Fall Congress. The NCDOT continues to urge only essential travel to the areas impacted by the storm since ongoing response efforts remain the priority and non-essential traffic hinders recovery. Most areas of Asheville, including downtown, are still without water service and some areas remain without power. Cellular service also continues to be spotty. The Renaissance hotel suffered both exterior and interior damage and is currently providing lodging and meals for 200 FEMA workers. Downtown restaurants and businesses are closed and nearby attractions like the River Arts District and Biltmore Village have experienced significant flood damage. We know the community is resilient and the city will bounce back, but relief efforts and infrastructure repair will take time.

Any progress made between now and the meeting should be dedicated to meet the needs of the residents and relief workers. The NCOS does not feel it would be appropriate for our group to consume resources that could otherwise go to those who need it most. It doesn't feel right.

With that said we are excited to announce that Fall Congress will take place at the Marriott hotel and Benton Convention Center in downtown Winston-Salem, NC. Conveniently located in the center of the state, the Marriott hotel and Benton Convention Center promises to provide a great meeting destination in a charming and vibrant city. The hotel is within easy walking distance to more than 45 restaurants, craft breweries, shops, galleries, and entertainment venues. Check out things to do and food and drink options.

The dates and agenda for the meeting will remain the same. All continuing education and meetings will take place at the Marriott hotel. The Friday and Saturday Partner lunches and Saturday evening event will take place directly across the street at the Benton Convention Center.

The room block rate at the Marriott hotel is \$174/night (<u>click here</u> to view location and parking guide). To make your room reservation <u>click here</u> or call (336) 725-3500. The room block closes on Thursday, October 31 or when it is full, whichever comes first.
